JULY15, 2010

The Alcohol Board Meeting as is custom, was held in the Courtroom at the Town Hall in Walker. Mr. Raiford, call the meeting to order and asked for roll call. Ms. Stevens called the roll, all members were present, Mr. Aydell, Mr. Hano, Mr.Loifton, Mr. Melson, Mrs. Streeter, & Ms. Torres

Mr. Raiford, apologize to the board for the lateness in getting their packets to them. He explained, that we were trying to get the new application for Walgreens Pharmacy ready. Mr. Faust, the Manger, of Walgreen Pharmacy, had a meeting with the Chief of Police the week before. The Chief got sick, so the meeting had to be re-scheduled. The new date was July 13<sup>th</sup>, we received the report on July14th . This completed their application, The only things left were this meeting and the Council meeting which is Aug. 9<sup>th</sup>.

Mr. Raiford introduced Mr. Norman Ray Faust as the Manager of Walgreen Pharmacy, at 10200 Fla. Blvd, Walker, La., Walgreen Pharmacy having completed the process necessary to obtain an Alcohol License, met with the ABC Board as part of this process. Mr. Raiford discussed with Mr. Faust the laws, rules, and regulations, he understood and advised Mr. Raiford and the Boards Members that the store had already taken steps to be sure anybody not having a Alcohol card could not use the cash registers to sell alcohol If anyone with out a card tries the register blocks that sale. Mr. Raiford asked, did any store employees have their cards, yes there are (22) people with their cards.. The last step is to met with Walker Town Council on Aug. 9<sup>th</sup>. We can not sent their Alcohol License until they furnish us with a copy of their State of La. Alcohol License. At this point Mr. Raiford thanked Mr. Faust for coming, and Mr. Faust left the meeting.

Next on the agenda was a letter to Mr. Jon McQueary, he is the new owner of Lafluer's Jr., Mr. McQueary came to renew the Occupation License for Lafluer' Jr. showing himself as owner, but he had Lafleur's Corp. listed on his application, He also needs an Alcohol License, there again he need to complete the process that is required..

The Town Attorney, Mr. Graves checked with the Sec. of State's office,& found that Mr. Queary is listed as the owner of the Corp.

We are waiting for him to come in to take care of business.

In other business Mayor Font came before the ABC Board to discuss some up coming changes. These changes are necessary basis on the up coming Alcohol Law vote, schedule for OCT. 02,2010. He gave each Board Member a booklet marked "Chapter 3 Alcoholic Beverages, (DRAFT). We will have several other meetings pertaining to this issue, the first one is on Aug. 9<sup>th</sup> following the Town Business meeting, the second one is scheduled for Aug 10<sup>th</sup> at 6:00pm. These meetings will be held at Walker Town Hall.

Mr. Raiford remind us that this needed to be published in the Livingston Parish News.


