Mayor Ramsey commented on the following;

- The City will be entering into a municipal lease agreement with Pitney Bowes for an up graded, more efficient postage meter system.
- The City will be entering into a municipal lease agreement with Advanced Office
 Systems which will provide more efficient copiers that are capable of accommodating our copy needs at cost saving rates.
- The City will be entering into a municipal lease agreement with Synovia Solutions which will provide GPS tracking systems for all city owned vehicles.
- The City policy regarding annual leave in cases where individuals have accumulated more annual leave than the policy allows, the accrual of leave will be suspended until leave hours fall below the maximum leave accruals allowed.
- Money was appropriated in the budget for a security system. We are in the process now of finalizing a lease agreement to provide security systems for every location within the city government.

Chief Marliam Lee presented the police report indicating that there were 388 citations, 1017 calls for service and 65 arrests during the month of May 2015.

Rev. Leon Goldmond from the audience asked a question regarding the bridge, traffic and pot holes on Travis Street. Mayor Ramsey informed him that the bridge work on Travis Street should start within the year, the street department will soon be working on the pot holes now that the weather has cleared, and that Travis Street was supposed to be on the list of roads for overlaying.

There being no additional business and nothing further to discuss Mr. Tracy Girlinghouse made a motion seconded by Mr. Paul Roberts to adjourn.
