## CITY OF WALKER COUNCIL MEETING MINUTES

September 8, 2014 6:00PM

The regular scheduled meeting of the Walker Mayor and City Council was held at the Walker City Hall on September 8, 2014 at 6:00pm. Present were Mayor Rick Ramsey, Council members Jonathan Davis, Tracy Girlinghouse, Gary Griffin, Scarlett Major and Paul Roberts.

The meeting was opened with prayer led by Mr. Gary Griffin.

Mr. Tracy Girlinghouse led the Pledge of Allegiance.

Mr. Paul Roberts made a motion, seconded by Mr. Jonathan Davis to adopt the minutes of the August 11, 2014 meeting as presented.

Mayor Rick Ramsey presented Mr. Cliff Graham and Mr. Darren Blevins with a key to the City of Walker. Mr. Graham donated 5 air conditioners to local citizens who are in need of help. Mr. Graham thanked the Mayor but told him that he, along with others, have made this their mission to serve God by serving others. Mr. Darren Blevins has started a nonprofit organization, **Showing Mom's A Little Love (SMALL)**. It is designed to help single mothers with low or no income. Mr. Blevins used the air conditioners Mr. Graham donated to help improve the lives of these single mothers and their families by showing God's love.

Ms. Cassie Felder, candidate for Congressmen, District 6 was unable to attend the meeting.

Mr. Jeff Johnson, candidate for District Judge, Division A addressed the Council and requested their support.

Mrs. Hebert was requesting that the Council consider barricades, speed bumps or one way streets to eliminate this problem.

Following discussion regarding the speed issue, Mrs. Scarlett Major made a motion, seconded by Mr. Tracy Girlinghouse to lift the agenda to introduce ordinances for Oak Street, Mr. Marsh and Mr. Hill property purchase and the request of Best Western to be placed on the City Utility system as well as to be annexed into the City limits of Walker.

Lieutenant Kenath Black presented the police report indicating 566 citations were issued, 1133 calls for service and 82 arrests were performed in July 2014.

Mayor Ramsey stated that the City had received their new bond rating from Standard & Poors indicating it had come up from the previous bond rating of A to A+.
